# IS A BUSINESS REQUIRED TO DELETE ONLY 12 MONTHS OF CONSUMER INFORMATION IN RESPONSE TO A REQUEST TO BE FORGOTTEN?

## No.

Unlike a request for access,<sup>1</sup> a business's deletion obligation extends to all data held by the business regarding a consumer, unless an exception applies, irrespective of when that data was collected, generated or processed. Neither the statutory text nor the regulations establish a "lookback period" for requests for deletion. That said, a business is not obligated to delete consumer information that it is required to retain to comply with a legal obligation.<sup>2</sup> As a consequence, a business may be required to retain data for a period of time under applicable law.
